A message from Crime Prevention Specialist Amy Lavender

Garage burglaries in Kenny neighborhood:

During the late evening hours of November 3 through the early morning hours of November 4, seven garage burglaries occurred. Five of these incidents involved the service doors being pried or forced. Two cases involved the service doors being left unlocked. The suspect(s) went through vehicles and stole money and other miscellaneous items from the cars. There is no suspect information available at this time.

The incidents occurred on the following blocks:

57XX Knox (2)

58XX Irving

58XX Sunrise Dr

56XX Bryant

54XX Colfax (2)

What You Can Do:

- Please remember to close and lock both the overhead doors and the service doors. Even though several of the incidents involved the doors being forced open, locks are still a deterrent.
- Consider installing motion lights and/or leaving lights on from dusk until dawn around your garage as well as your home. Having an area well-lit is a deterrent for criminals.
- Service door locks are often flimsy and easily breeched. Think about replacing the locks with deadbolts and/or reinforcing the frame with 2x4s.
- Call 911 on any suspicious activity.

Forced entry property crimes

Moore, who has been arrested in Minneapolis 8 times in the past year, has prior convictions in Hennepin County for possession of marijuana in a vehicle, driving while intoxicated, fleeing police in a motor vehicle, theft, 3rd degree assault causing significant bodily harm, and 1st degree aggravated robbery. November 3 At about 10:45 p.m., officers noticed a strong odor of marijuana coming from a vehicle which was parked on the 4600 block of West Lake Harriet Parkway in Linden Hills. The passenger in the vehicle, 20-year-old Kearstin Michelle Holsopple of Hopkins, was cited for petty misdemeanor possession of a small amount of marijuana.
