## Crime reports

**October 9** At about 8:35 p.m., a manager at the <u>Holiday store at 3700 West 50<sup>th</sup> St</u> saw a male suspect take an instant food item, tear the wrapper off, and put it in a microwave. The suspect then tried to leave the store without paying. The manager confronted the suspect and told him that he had to pay for the food. The suspect replied that he brought the food from home to heat up. The manager and the suspect got into a verbal argument. The suspect then left with the food without paying, got into a vehicle with a female driver, and left the area. The manager gave the license plate number of the vehicle to police.

October 13 At about 1:50 p.m., a suspect took a bike from a garage on the 5300 block of Chowen.

Officers arrived and determined that the incident was an aggravated robbery of person. 33-year-old Lakeric Cortez (or Cortex) McCaskill was arrested and booked in the jail but released from custody on October 18 without being charged. The police report gives the suspect's address as 2430 Portland Ave; the jail roster lists his address as 5047 Sheridan Ave, which is a duplex owned by the Minneapolis Public Housing Authority. McCaskill has prior convictions in Hennepin and Anoka Counties for aiding / abetting 1st degree burglary, fleeing police in a motor vehicle, consuming alcohol in public, open bottle, disorderly conduct, and prohibited person in possession of a firearm.

October 17 At about 11:15 p.m., two squads responded to a burglary of dwelling in progress at an address on the 4400 block of Xerxes in Linden Hills. 22-year-old David James Peake of 5133 Zenith Ave was arrested for burglary of dwelling and criminal damage to property, booked in the jail, charged for those offenses, and then conditionally released on October 20.
