## Fulton Safety Committee report – October, 2009

Below are summaries of crime reports from Fulton, Linden Hills, Lynnhurst, Armatage, and Kenny neighborhoods during October. No reports were compiled during September.

## **Unsecured property**

**October 8** Between 9 p.m. and 9:30 a.m., an unknown suspect stole a vehicle which was parked in the driveway of a residence on the 3800 block of Chowen in Linden Hills. The victim was uncertain about whether the vehicle was locked, and stated that an ignition key was in a bag in the trunk. There was no broken glass at the scene and no sign of forced entry.

**October 8** Between 11 p.m. and 6 a.m., an unknown suspect entered a vehicle which was parked on the street on the 4700 block of Chowen and took cash. The suspect rummaged through the glove box and center console and left numerous valuable items behind. The victim stated that the vehicle may have been unlocked. There was no sign of forced entry.

**October 10** Between 9 p.m. and 9:30 a.m., an unknown suspect entered a vehicle which was parked in the rear driveway of a residence on the 6000 block of Knox in Kenny and stole an iPod. The victim stated that the vehicle was possibly left unlocked. There was no sign of forced entry.

## **Arrests**

**September 30** At about 1:40 a.m., officers observed a male, who appeared to be a juvenile and out past curfew, in an alley on the 5800 block of Washburn in Armatage. During a search of the suspect, officers saw a knife clipped into the suspect's rear pocket. The blade was longer than four inches. The suspect told officers that he carries the knife for protection and that he has enemies in the neighborhood. 19-year-old Adam Lloyd Tymeson of 6037 Penn Ave South was cited for carrying a weapon without a permit.

**October 4** At about 6:50 p.m., officers were dispatched to an address on the 5800 block of Washburn in Kenny on a disturbance. 18-year-old Aaron Devord Rogers of 5854 Washburn Ave South was arrested for a misdemeanor warrant for trespassing and unlawful possession/sale/distribution of narcotics from August 5, 2009. Rogers had failed to appear in court on September 9. On October 5, Rogers pled guilty to trespassing, with a stay of imposition; the other charge was dismissed. Conditions of release include unsupervised probation for one year with no same or similar offenses, no drug-related offenses, and no lurking.

## Robbery

**October 10** At 12:50 p.m., a suspect entered Shop in the City, 3018 West 50<sup>th</sup> St, threatened the clerk with a knife, took money, and fled.
