50th Street Plans

A Letter from Commissioner Gail Dorfman

I have received much feedback on the 50th Street re-striping plan from people who use 50th and who live and work in the surrounding neighborhoods. The 50th Street Task Force, composed of business and neighborhood representatives, has met several times over the past year with city and county staff. All have worked diligently to make improvements to the plan. The focus since the May 5th community meeting has been to achieve a win-win scenario that meets the following goals: reduce traffic speeds, improve traffic flow and pedestrian safety, and retain as many parking spaces as possible within the business nodes. I believe that a compromise has been reached that balances the interests of businesses and neighbors with smoother and safer traffic flow along this busy corridor.

These are the major points of the compromise plan:

- Parking is allowed on both sides of the street in the business nodes.
- ♦ There will no longer be any AM/PM parking restrictions.
- ♦ Sixteen additional on-street parking spaces in three business nodes have been identified since the May 5th plan.
- ♦ Left turns will be prohibited at peak hours one block east and west of the business node intersections.
- ◆ Traffic signals at Xerxes and Penn will have left turn signals.
- A three-foot pedestrian buffer will be added next to the sidewalks.
- Bus stops will be moved to provide a stop every two blocks.

Penn Avenue Bridge Construction

Many residents in Fulton have inquired about the status of the renovation of the Penn Avenue Bridge. Public Works spoke at the October 8 board meeting of FNA to update the neighborhood on this project.

A number of unexpected factors have delayed this project from the beginning. A rise in the creek level that flooded the site slowed the work. The crew also discovered an unused set of bridge footings below the creek bed, which were not shown on the construction documents from 100 years ago. In addition, the design of the system intended to install the new façade failed and all the façade work installed to that point had to be removed. The manufacturer is currently examining the system and will be recommending a new approach.

Completed is the structural work on the barrel extension in the creek and the majority of the stones placed along the shoreline for erosion control. On top of the bridge, the curb, 400 feet of paving, and east side sidewalk along with temporary asphalt sidewalks are complete. In early November, the west side sidewalk and the railings over the barrel sections will be completed.

The bridge design consultant is reviewing the manufacture resolution to the façade design. Public Works is anticipating work can resume on that part of the project in November. They are planning on working through the winter, as weather permits. The estimate for the work is six weeks per side of the bridge.

Next spring, Public Works will complete the landscaping and tree planting along the shoreline, bridge top and in the park.

Traffic engineers studying the Bryant intersection recognize its uniqueness due to heavier traffic volumes and its proximity to Lyndale Avenue. The parking solutions that add back parking spaces in the other three nodes don't work for Bryant. The Bryant business owners have begun to discuss options for the development of off-street parking in this area. It has therefore been recommended that the re-striping from Lyndale to Dupont be done at a later date in conjunction with the reconstruction of Lyndale Avenue.

The timetable for implementation of the compromise plan is to have all the work completed by the third week of June 2004. The City of Minneapolis will be responsible for the traffic signal improvements, signage, and seal coating of the road. Metro Transit will make the bus stop location changes. Hennepin County crews will do the re-striping. Costs for the re-striping will be paid for out of the regular road maintenance budget allotted to 50th Street.

I believe that this 50th Street compromise is the win-win solution that both neighbors and business owners have been working towards. The new plan reflects solutions to concerns raised by business owners and residents. Again, I appreciate the input and involvement of so many neighbors who have an interest in creating a safer, better 50th Street.

Fall Street Sweep and Leaf Collection Help Protect Lakes and Creek

Minneapolis began its annual comprehensive fall street sweeping on Tuesday, Oct. 21. City officials are reminding residents not to rake their leaves into the streets and to watch for "No Parking" signs as crews methodically sweep neighborhoods throughout the city. Officials remind Minneapolis residents to collect fallen leaves on their yards and sidewalks and bag them up - Public Works crews will pick up yard waste during weekly garbage pickups (through the week of Nov. 18). City Ordinance prohibits the sweeping of debris and yard waste into the streets. Leaves wash into storm drains and end up in Minneapolis' lakes, streams and the Mississippi River. Leaves and nutrients over-fertilize our waterways and lower water quality in our region.

City Budgeting for 2004

City Budget Adoption December 16th

A Truth and Taxation public hearing has been tentatively scheduled for December 8 at the City Council chamber and the final approval of the City's 2004 Budget is scheduled to happen at a special Council meeting on Tuesday, December 16.

Park Board Public Hearings November 5 & 12

Minneapolis Park & Recreation Board will hold two more public hearings on November 5 and 12 to continue listening to residents on the proposed 2004 budget cuts. Both meetings will begin at 6:30 p.m. at the Park Board headquarters at 2117 W. River Road. Preliminary adoption of the budget

will be done on November 5 with final adoption of the budget in December. Cuts in Local Government Aid (LGA) made at the state legislature last spring reduced the Park Board budget by \$4.07 million. That LGA reduction along with higher health care costs and fewer dollars coming from property taxes and state grants meant that the Park Board had to reduce its overall budget for 2004 by 10 percent. Specific areas for proposed cuts and new revenue generating activities are outlined and available on the city website.
